Springfield is a more dangerous city to drive in than St. Louis, though it is MUCH smaller.</p> <p>Most municipalities rely heavily on traffic enforcement revenues to shore up their police and fire department. That is certainly not happening here in Springfield, nor has been for a long time.</p> <p>Essentially the Police Department is under funded because of their neglect to enforce traffic laws. The end result is a city in trouble financially as well as a dangerous place to drive due to this lack of enforcement.</p> <p>Why on earth hasn't this been investigated? As a concerned citizen I wonder how long it will be before one of the many citizens watchdog groups files suit against the police department for long term failure to protect its citizens.
