Aco Report from Aco/Heather Ferrier

I spoke with Kaitlyn Riggs, the owner of the dog. She states that Breck Ruddick was caring for her dog when the incident happened. He allegedly punched the dog in the face 3 times, and then turned him loose. After Kaitlyn found the dog, she took him to the vet (Animal Care on south Campbell). the vet told her that the dogs jaw was broken and atleast 6 teeth were cracked. Kaitlyn wants to pursue cruelty charges. She has text messages that show Breck admitting to beating the dog, vet records, video, etc. She asked me to wait until later in the evening to contact Breck to ensure that his parents would continue to pay the vet bill. She was afraid if I confronted him right then, that they wouldnt pay the entire bill. I told her that it was not a time sensitive matter and I could wait until monday to make contact. She understood and was in agreement.

Breck lives at [REDACTED]. he is at an away football game this weekend, i will attempt contact monday.
