Review of Public Input Process:

The vision for Jordan Valley originated from the roots of the citizen-driven Vision 20/20 comprehensive planning process in the mid-1990s. Over 18 months, more than 350 citizens attended 500 meetings and spent some 25,000 hours molding their ideas into a comprehensive plan for the future of Springfield and Greene County. Through this process general recommendation for West Meadows were formed and included in the Jordan Valley Concept Plan. More recently, a public input process was conducted through 2006-2007 to reengage the public and develop more focused recommendations for the West Meadows, the Quarry, and remainder of East Meadows. The results of this process were published in the planning document *A Vision for Jordan Valley* adopted by City Council and on file in the Department of Planning and Development. The Jordan Valley Concept has been updated to reflect concepts within *A Vision for Jordan Valley*.

Key recommendations from “A Vision for Jordan Valley” for West Meadows

- Open Space
- Greenways Trails
- Stormwater – Corps Study
- Rail Reconfiguration

Open Space

Environmental Assessments and Findings

- Phase I - identified historical land use as an environmental concern – e.g. rail yard and associated industrial operations
- Phase II
 - Contamination covers approx. 75% of site - top 4’-8’ of soil – fill materials
 - More soil impacts in central and west-central portions
 - No significant groundwater impacts
 - Contamination consistent with historical land use
 - 19,000 cubic yards of concrete

Next Steps

- **Cleanup Planning – In Process**
 - Analysis of Brownfields Cleanup Alternatives (ABCA)
 - Public Meeting
 - 30 Day Public Comment Period
 - Develop Remedial Design/Cleanup Plan
- **Site Cleanup – Begin 2010**
 - Begin with Sites 1, 2, 3, and 4 using EPA Brownfields Grant funding

- Achieve Department of Natural Resources Certificate of Completion for each site
- Cleanup remaining sites 5-8 as funding becomes available

These Brownfields assessments and cleanup activities are merely the first step towards accomplishing the project and opening the property to the public for reuse.
