SPECIAL ORDINANCE NO. _____

AN ORDINANCE

1 TO LEVY AND ASSESS a special tax against the lots, blocks, and parcels of ground
2 hereinafter described to pay for the cost of the construction
3 of sanitary sewers in the City of Springfield, Missouri, in
4 Sanitary Sewer District No. 110 of Section No. 5, in the
5 general vicinity of Missouri Avenue at Woodridge Street,
6 providing for inclusion of said district in the City Sewer
7 Financial Assistance Program, and authorizing the City Clerk
8 to issue special tax bills and deliver the same to the Director
9 of Finance to be registered in his office in accordance with
10 the ordinance.

14 BE IT ORDAINED BY THE COUNCIL OF THE CITY OF SPRINGFIELD, MISSOURI, as
15 follows that:
16

17 Section 1 - There is hereby assessed against the lots, blocks, and parcels
18 of ground hereinafter described, to be levied and issued as provided for herein, special
19 tax bills to pay for the cost of construction of sanitary sewers in Sanitary District No. 110
20 of Section No. 5.
21

22 Section 2 - The Sanitary Sewer District No. 110 of Section No. 5 will be
23 included within the City Sewer Financial Assistance program under Chapter 98, Article
24 VI, Section 98-286(4)b of the Springfield City Code.

26 Section 3 - The City Clerk is authorized and directed under the seal of the
27 City of Springfield, Missouri, to issue special tax bills in the name of the City against the
28 hereinafter described lots, blocks, and parcels of ground for the respective amounts

29 assessed against the same to pay for the cost of such construction and deliver the
30 same to the Director of Finance.

31
32 Section 4 - Said tax bills shall be made payable in fifteen (15) equal
33 annual installments becoming due together with interest to date on each anniversary
34 date after the issuance thereof for a period of fifteen (15) years respectively after the
35 date of issuance of the tax bills; provided, however, that the person paying such tax bills
36 shall have the right to pay the same in part or in full within thirty (30) days after the
37 issuance thereof with no interest and shall have the further right to pay any combination
38 of annual principal payments or the unpaid balance of said tax bills with interest thereon
39 up to the date of payment, within thirty (30) days after the end of any yearly period when
40 any installment is payable. In addition to the above, tax bills may be paid in full at any
41 time during the year with interest thereon up to the date of payment.

42
43 Tax bills so issued shall be made payable in accordance herewith and if
44 any annual installment of principal and interest thereof is not paid within thirty (30) days
45 after it is due, then all the remaining installment with interest thereon shall at once
46 become due and payable and payment of the entire amount of such tax bill remaining
47 unpaid, may be demanded and enforced by the owner of such tax bill. The lien thereof
48 shall continue for sixteen (16) years from the date of passage of this ordinance, or one
49 (1) year after the last installment becomes due, unless sooner paid, or in the event suit
50 be brought to enforce the collection of such special tax bill under such lien, then until the
51 expiration of the litigation.

52
53 Section 5 - The City Council hereby sets the interest rate on the sewer tax
54 bills to be issued by the City for Sanitary Sewer District No. 110 of Section No. 5 to be
55 the same percentage rate of annual interest that is payable by the United States of
56 America on 10-year Treasury notes at the most recent auction before the date of the
57 issuance of the sewer tax bills, as is set forth in Section 88.812 of the Revised Statutes
58 of Missouri.

60 Section 6 - The City Manager has caused to be computed the entire cost
61 and expense of the aforesaid improvement, including any cost or expense incurred by
62 the City, and the amounts herein charged, assessed, and levied have likewise been so
63 computed and are assessed and levied ratably against all lots and tracts of land within
64 the district in proportion to the area thereof and are as follows, to wit:

 114 assessed for the payment of said construction is \$39,610.91. The rate of assessment is
 115 \$1,215.80 per thousand square feet as provided for by Special Ordinance No. 25631,
 116 passed by the City Council on July 13, 2009, and Resolution No. 9692, passed by the
 117 City Council on June 15, 2009.

EXPLANATION TO COUNCIL BILL NO. 2009 - _____

ORIGINATING DEPARTMENT: Public Works

PURPOSE: To levy and assess special tax bills for the construction of sanitary sewers in Sanitary Sewer District No. 110 of Section No. 5 in the City of Springfield, Missouri, located in the general vicinity of Missouri Avenue at Woodridge Street.

REMARKS:

HISTORY

1. This project was scheduled for construction as part of the City's 10-year sewer construction program to eliminate septic tanks within the City limits and to encourage infill by providing sanitary sewer service.
2. Special Ordinance No. 25546, passed by City Council on February 9, 2009, established and defined the boundaries for Sanitary Sewer District No. 110 of Section No. 5.
3. Plans, specifications, and a cost estimate have been prepared by Public Works.
4. Wastewater from this district would flow to the Northwest Wastewater Treatment Plant.
5. The project was advertised in the *Daily Events* on March 11, 2009, through March 13, 2009.

40 6. Bids were opened in the Busch Building on June 2, 2009, at 10:00 a.m. The
41 following bids were received:

54 7. Letters have been mailed to property owners in the district with information
55 regarding the proposed sewer construction, related costs, and available
56 assistance programs.

57
58 8. Resolution No. 9692, passed by City Council on June 9, 2009, declared it
59 necessary to construct sanitary sewers in Sanitary Sewer District No. 110 of
60 Section No. 5.

61
62 9. Resolution No. 9692 was published in the *Daily Events* on June 22, 2009,
63 through June 26, 2009. The resolution was also posted in three locations within
64 the district. A valid remonstrance has not been filed.

65
66 10. Special Ordinance No. 25631, passed by City Council on July 13, 2009, accepted
67 the bid of Monger Construction, Inc., in the amount of \$44,792.26.

68
69 11. Construction has been completed and the project accepted. The actual total cost
70 of construction is \$39,610.91. This project provides sewer to 3 properties and
71 will eliminate 3 septic systems.

72
73 12. The tax bill rate based on actual construction costs for Sanitary Sewer District
74 No. 110 of Section No. 5 computes to be \$1.215804481 cents per square foot of
75 property.

76
77 13. The City will hold the tax bills for all properties within the district at 3.625%
78 interest for 15 years.

79
80 14. The property owners have been notified of their tax bill amount along with the
81 following information about several of the available programs, to assist property
82 owners with the costs associated with the sewer tax bill and sewer hookup. The
83 City Sewer Financial Assistance program provides residential property owners
84 the opportunity to take advantage of a \$7,300 per tract cap on the tax bill

85 amount. A low-interest loan to help with costs for hookup to the sewer is
86 available through the Sanitary Services Division. The Sanitary Sewer Installation
87 and Connection Assistance program provides two types of assistance for low-
88 and moderate-income families. One provides a deferred, no-interest loan for
89 sewer hookup costs. The other is a direct grant to offset the cost of the tax bill.
90 The City also provides a 15-year, low-interest payback arrangement for tax bill
91 costs.

93 15. The Public Works Department recommends passage of this Council bill.
