However, the water in my basement was mostly sewage that had backed up from my floor drain. This has been the situation each time this basement has flooded. I live on Nichols Street, and the sewer main runs directly behind my house in the alley. I know from observation that the people living in the houses on Scott Street who also have basements are experiencing the same flooding. It seems that the storm sewers in this area feed into the sanitary sewer, which is not of an adequate size to handle downpours like we have had this week. In addition, the ditches along Franklin Avenue cannot handle the deluge, adding to the problem.</p> <p>In 2008, my family and I lost about \$3000 of property, as well as many irreplaceable items such as photographs, keepsakes, and one-of-a-kind handmade tools my father and grandfather had made. I contacted Public Works, and they assured me the sewer system was clear, it was just overtaxed due to the heavy rainfall. To add insult to injury, when I removed the destroyed items from my basement, as had my neighbors, I received a letter from the Health Department demanding I remove the "trash" from my property. I did not have the money at the time to haul the items away. I explained this to the worker from the Health Department, and she was unsympathetic. Well over three truckloads and one hundred dollars in fees later, the property was removed.</p> <p>Since I work in a hospital, I am aware of infection control. In my eyes, there is far greater danger in raw sewage backing up in someone's home than there is in property damaged from said raw sewage sitting in a backyard until it can be haul</p>
