

## Market Development

Market development efforts include:

- **Product supply development**—Springfield is committed to increasing both the quantity and quality of existing items recycled, as well as the variety of items recycled in order to provide a reliable, high-quality supply source to manufacturers.

- **End user identification and materials exchange**—Springfield is actively seeking out companies or manufacturers which use recyclables as raw materials in their manufacturing processes. One component of the Business Recycles program is the identification of items available and items needed in an effort to keep these items out of the waste stream. The City facilitates dialog between the supply source and the end user.

- **Working with the City's Economic Development staff and the Springfield Area Chamber of Commerce to target and encourage businesses** who utilize recyclables in their production to relocate or expand their operations to Springfield. In this way, the recyclables stay in Springfield and, among other advantages, transportation costs are minimized. This is mutually beneficial and closes the recycling loop.

We will attempt to network you with a source or market. We do not make referrals, but we do maintain an information bank. We also offer waste reduction consulting services to assist you in identifying recyclables and reducing your solid waste, as well as assistance in initiating a recycling program for your business or organization.

## Springfield Sanitary Landfill

Springfield is continuing to focus on reducing its solid waste stream through precycling, recycling, reuse, and numerous other means; however, the Springfield Sanitary Landfill remains a vital part of the solid waste management plan in Springfield. While other revenue sources are being pursued, Landfill tipping fees are the major funding source for the City-provided components of our Integrated Solid Waste Management System.

A stormwater management system, including a series of channels diverting stormwater around the Landfill and a 14-million gallon stormwater sedimentation basin, ensures the quality of stormwater leaving the Landfill area. All leachate is captured and transported to the Northwest Wastewater Treatment Plant for proper treatment. Monitoring wells surrounding the Landfill area monitor the groundwater.

**The Mission of the City of Springfield's Solid Waste Management Division is to provide an Integrated Solid Waste Management System for Springfield and Greene County that is environmentally sound and economically feasible which represents a long-term solution to preserve the natural resources of the region for present and future generations.**

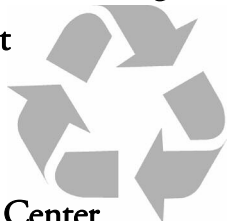

## Springfield's Integrated Solid Waste Management System

Springfield's Integrated Solid Waste Management System consists of a variety of successful programs and services, including:

- All licensed trash haulers in Springfield are required to offer the convenience of **curbside collection of recyclables**.
- The City operates a **Household Chemical Collection Center** for residents of Springfield and Greene County.
- An ongoing program of **information and education** is in place, including the **Recycling Hotline** service (864-1904) and Web site: [www.springfieldmo.gov/recycling](http://www.springfieldmo.gov/recycling)
- Efforts to develop new markets and to expand existing markets for recyclables are ongoing.
- Non-recycled waste is taken to the Springfield Sanitary Landfill, and sound Landfill management is an integral part of the System.
- Yardwaste is composted and brush is chipped into landscaping mulch at the City's Yardwaste Recycling Center.
- Pilot programs and grantseeking assistance are offered to broaden and test emerging technology.
- Staff members attend conferences and seminars to keep informed of the latest developments.
- Convenient Recycling Centers are offered for residents.

Any one of these programs or services could not stand alone as the answer to the complex challenges facing today's municipal solid waste managers. Yet, when utilized as a part of the Integrated Solid Waste Management System, the combined effect on the reduction of our waste stream is significant.

## Curbside Recycling

Curbside collection of recyclables is provided through all Springfield waste haulers. Curbside recycling is the easiest, most convenient method of recycling. It eliminates the need to store recyclables, load them in your car, then take them to a Recycling Center and unload them. You simply set the recyclables by your curb on your designated collection day. That's all there is to it. And since weekly collection is available, there will be no more stacks of recyclables taking up space in your home or garage. Rates charged, items accepted and frequency of collection vary among waste haulers. Call your waste hauler to sign up for curbside recycling today.

## Household Chemical Collection Center

Springfield's Household Chemical Collection Center (HCCC) accepts household-generated chemical waste. Opened in August 1994, the HCCC was the first year-round facility of its kind in the State of Missouri.

More than 80% of the material collected is recycled or reused. The balance is disposed in an environmentally sound manner.

This facility allows citizens to remain in their vehicle while technicians remove the chemicals or items from the vehicle. The average trip through the covered drive-through facility totals five minutes or less.

State regulation allows for only chemicals from households to be accepted. Small businesses needing assistance should contact the Missouri Department of Natural Resources Environmental Assistance Office (EAO) at 800-361-4827.

## Yardwaste Recycling Center

The Yardwaste Recycling Center, located near the Southwest Wastewater Treatment Plant, is both efficient and convenient—residents bring in their yardwaste and brush and may take home high-grade wood mulch and compost. This popular service is utilized by an average of 150 Springfield/Greene County residents per day.


Hours of operation are


- 8 a.m. - 5 p.m., Tuesday through Saturday, during Standard Time.
- 8 a.m. - 6 p.m., Tuesday through Saturday, during Daylight Savings Time.
- During Peak Season, the Center is also open Sundays 1 p.m. - 5 p.m. (Call the Recycling Hotline 864-1904 to confirm).
