7 WHEREAS, on November 10, 2014, City Council adopted Ordinance 26484  
8 which authorized the City to enter into an Intergovernmental Agreement ("Agreement")  
9 with the School District of Springfield R-12 to share in the costs of a school crossing

12 WHEREAS, the Agreement authorizes the City and School District to extend the  
13 agreement through June 30, 2019; and

15 WHEREAS, the City and School District desire to extend the terms of the  
16 Agreement until July 31, 2020.

18 NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF  
19 SPRINGFIELD, MISSOURI, as follows, that:

21 Section 1 – The City Manager, or his designee, is hereby authorized to execute  
22 on behalf of the City an addendum to the Intergovernmental Agreement between the  
23 City and School District of Springfield R-12, identified as Contract No. 2014-1429, said  
24 addendum to be in substantially similar form as that document attached hereto and  
25 incorporated herein by this reference as "Exhibit A."

**EXPLANATION TO COUNCIL BILL 2019- 158**

FILED: 06-25-19

ORIGINATING DEPARTMENT: City Manager's Office

PURPOSE: Authorizing the City Manager to execute an addendum to the Intergovernmental Agreement between the City and School District of Springfield R-12 for the purpose of sharing the costs of a third-party vendor to operate a school crossing guard program for one additional year.

REMARKS:

On November 10, 2014, City Council adopted Ordinance 26484. This Ordinance authorized the City to enter into an Intergovernmental Agreement ("Agreement") with the School District of Springfield R-12 to share in the costs associated with a third-party vendor's operation of a school crossing guard program inside the City (Contract No. 2014-1429). The initial costs of the crossing guard services were \$140,900, with the City agreeing to pay \$105,000 and the School District agreeing to pay \$35,900. The parties agreed to pay 50% of any increase above the \$140,900 amount. A later addendum clarified, among other things, that the City and School District, in the event of a renewal of the Agreement, would each pay 50% of any increase above the \$140,900 for the crossing guard services.


The initial Agreement authorized the City and School District to extend the term of the contract for four additional one-year terms. The City and School District have utilized all of the currently authorized extensions.

The Addendum proposed as part of this Ordinance authorizes the City and School District to extend the term of the contract through July 31, 2020. The City and School District desire to extend the Agreement for an additional one-year term to allow more time for the City and School District to collaborate on the Request For Proposals regarding school crossing guard services in the City.

Extending the Agreement requires City Council action.

The parties agree as follows:

1. That paragraph 4 of the "Intergovernmental Agreement for Crossing Guards" is hereby deleted and replaced with a new paragraph 4 which reads as follows:
  4. Term. The term of this agreement will begin on January 1, 2015 and end on July 31, 2020.
2. That all other provisions of the "Intergovernmental Agreement for Crossing Guards" shall remain in full force and effect.
3. That this Addendum, together with the Agreement and any other previous addenda, contain the entire agreement of the parties. No modification, amendment or waiver of any of the provisions of this Addendum, shall be effective unless in writing specifically referring hereto and signed by both parties.
