AN ORDINANCE

1 AUTHORIZING the City Manager, or his designee, to accept a grant from the
2 Walmart Community Grant Program to participate in the annual
3 Shop with a Hero Program; and amending the budget of the Police
4 Department for Fiscal Year 2019-2020 in the amount of

8 WHEREAS, the Springfield Police Department (“SPD”), received a grant from the
9 Walmart Community Grant Program to participate in the annual Shop with a Hero
10 Program; and

12 WHEREAS, the Shop with a Hero Program provides the opportunity each year
13 for underprivileged children in our community to go Christmas shopping with law
14 enforcement, fire and military personnel; and

16 WHEREAS, SPD was awarded \$13,500.00 to participate in the program, along
17 with members of the Springfield Fire Department.

19 NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF
20 SPRINGFIELD, MISSOURI, as follows, that:

22 Section 1 – The City Manager, or his designee, is hereby authorized to accept
23 grant funds in the amount of \$13,500.00 from the Walmart Community Grant Program,
24 for use by the Police Department to participate in the Shop with a Hero Program, and to
25 do all things necessary to accept and to carry out the grants, including the execution of
26 contracts, provided the form of any such contract is approved by the City Attorney, or
27 designee.

29 Section 2 – The budget of the Police Department, for Fiscal Year 2019-2020, is
30 hereby amended in the accounts and in the amounts as shown on Budget Adjustment
31 No. 027 in the Amount of \$13,500.00, a copy of which is attached hereto and
32 incorporated herein by reference as “Exhibit A.”
33

34 Section 3 – City Council finds that the budget adjustment made above has been
35 recommended by the City Manager.

37 Section 4 – The City Manager is directed to cause the appropriate accounting
38 entries to be made in the books and records of the City. In the event additional funding
39 is provided under this grant by the grantor, the Director of Finance is hereby authorized
40 to adjust this appropriation by an amount not to exceed 20 percent.

42 Section 5 – This Ordinance shall be in full force and effect from and after
43 passage.
