7 approving a petition to re-establish the Kansas and Kearney Community Improvement
8 District (“CID”); and

10 WHEREAS, said Ordinance provides that the CID shall be governed by a five-
11 member Board of Directors (the “Board”); and

13 WHEREAS, said petition established the qualifications of, and process for
14 appointment of members to the CID Board through appointment by the Mayor with
15 confirmation by City Council; and

17 WHEREAS, there is currently a need to appoint two members to the Board of
18 Directors; and

20 WHEREAS, the Mayor of the City of Springfield, Missouri, has recommended the
21 appointment of John L. Hulston and John P. Hulston.

23 NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF
24 SPRINGFIELD, MISSOURI as follows, that:

26 Section 1 – City Council hereby confirms the appointment of John L. Hulston and
27 John P. Hulston to the Kansas and Kearney Community Improvement District Board,
28 with each person’s term to expire on October 21, 2021.
