SPECIAL ORDINANCE _____

AN ORDINANCE

1 AUTHORIZING the City Manager, or his designee, to enter into a First Addendum to
2 the Intergovernmental Agreement with Ozarks Technical Community
3 College regarding cooperative training between the Springfield Fire
4 Department and Ozarks Technical Community College for the purpose
5 of extending the term of the existing agreement.

8 WHEREAS, the Springfield Fire Department (“SFD”) and Ozarks Technical
9 Community College (“OTC”) have a long tradition of providing firefighter training in the
10 Springfield area; and

12 WHEREAS, in 2012 the City of Springfield entered into an Intergovernmental
13 Agreement with OTC for the purpose of providing shared facilities and cooperative
14 training between SFD and OTC; and

16 WHEREAS, in 2019 the City of Springfield and OTC entered into a revised
17 Intergovernmental Agreement with OTC for the purpose of updating the 2012
18 Agreement to ensure continued cooperation; and

20 WHEREAS, the 2019 Agreement is currently scheduled to expire on April 2,
21 2024; and

23 WHEREAS, SFD and OTC wish to extend the term of the existing agreement
24 until June 30, 2024, so that the expiration of the agreement and timing of any renewals
25 will coincide with the fiscal year observed by each entity.

27 NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF
28 SPRINGFIELD, MISSOURI, as follows, that:

30 Section 1 – The City Manager, or his designee, is hereby authorized to enter into
31 a First Addendum to the Intergovernmental Agreement with OTC executed on March
32 29, 2019. Said Addendum shall be substantially in the same form and content as that
33 document attached hereto and incorporated by reference as “Exhibit A.”



EXPLANATION TO COUNCIL BILL 2021-020

FILED 01-05-21

ORIGINATING DEPARTMENT: Fire

PURPOSE: Authorizing the City Manager, or his designee, to modify the period of the Intergovernmental Agreement (“IGA”) between the City of Springfield (“City”) and the Community College District of Central Southwest Missouri, AKA Ozarks Technical Community College (“OTC”).

BACKGROUND INFORMATION: The City of Springfield Fire Department (“SFD”) and OTC have a long tradition of providing firefighter training in the Springfield area, and have shared facilities and training props since 2012.

On March 11, 2019, the City and OTC entered into a revised IGA through Special Ordinance 26115, with the period of the IGA being valid for a term of five-years (5) from the date of ratification, resulting in the expiration of the IGA to be April 2, 2024.

Modification and extension of the period of the IGA to June 30, 2024, to coincide with the fiscal year observed by OTC, will facilitate opportunity for use of grant funds by OTC for sustainment and enhancement of OTC supplied apparatus, equipment and training props.

REMARKS:

The primary education and training facility for the OTC Fire Science Program is at SFD Fire Station 6 and the Regional Police and Fire Training Center.

First Addendum to
INTERGOVERNMENTAL AGREEMENT OF TRAINING PARTNERSHIP

Between

City of Springfield/Springfield Fire Department

And

Community College District of Central Southwest Missouri aka Ozarks Technical Community College

Entered into this _____ day of _____, 20__, for good and valuable consideration, the undersigned hereby agree that this Addendum shall become part of the Intergovernmental Agreement of Training Partnership (the “Agreement”) executed on the 29th day of March, 2019.

The parties agree as follows:

- 1. Paragraph 30 of the Agreement, appearing on page 8, is deleted and replaced with a new Paragraph 30 which shall read as follows:

“30. The term of this agreement shall be from the date it is signed by the parties until June 30, 2024. Upon the end of the term, any needed revisions may be considered prior to renewal of the agreement. Either party wishing to terminate the agreement may do so with 30 days notice at the end of the agreement period.”

- 2. All other provisions of the Agreement shall remain in full force and effect.
- 3. This Addendum, together with the Agreement contain the entire agreement of the parties. No modification, amendment, or waiver of any of the provisions of this Addendum shall be effective unless in writing specifically referring hereto and signed by both parties.
