13 number of times, with its most recent extension having been approved by Special
14 Ordinance 26746 on June 21, 2016; and

16 WHEREAS, said petition establishes the qualifications and process for
17 appointing members of the CID Board of Directors through appointment by the Mayor
18 with confirmation by City Council; and

20 WHEREAS, there is presently a need to reappoint members to the Board of
21 Directors; and

23 WHEREAS, the Mayor recommends the reappointment of Chris Ball, Bart Tacke,
24 Ken Chumbley, Bruce Adib-Yazdi and Dick Scott to the Downtown Springfield
25 Community Improvement District Board of Directors.

27 NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF
28 SPRINGFIELD, MISSOURI, as follows, that:
