SPECIAL ORDINANCE _____

AN ORDINANCE

1 AUTHORIZING the City Manager, or his designee, to accept a grant from the
2 Greene County Senior Citizens' Services Fund Board for the benefit
3 of the Give 5 Program; and amending the budget of the City of
4 Springfield, for Fiscal Year 2017-2018, in the amount of \$92,350 to
5 appropriate said grant funds.

8 WHEREAS, on January 29, 2018, City Council authorized the City Manager to
9 apply for an additional grant from the Greene County Senior Citizens' Services Fund
10 Board to operate the Give 5 Program in calendar year 2018; and

12 WHEREAS, the Greene County Senior Citizens' Services Fund Board has
13 awarded grant funds for the operation of the Give 5 Program in calendar year 2018; and

15 WHEREAS, this Ordinance accepts said grant funds and appropriates said funds
16 for the benefit of the Give 5 Program.

18 NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF
19 SPRINGFIELD, MISSOURI, as follows, that:

21 Section 1 – The City Manager, or his designee, is hereby authorized to accept
22 grant funds from the Greene County Senior Citizens' Services Fund Board for the
23 benefit of the Give 5 Program and to do all things necessary to carry out the grant.

25 Section 2 – The budget for Fiscal Year 2017-2018 of the City of Springfield is
26 hereby amended in the accounts and in the amounts as shown on Budget Adjustment
27 No. 0027, a copy of which is attached hereto and incorporated herein by this reference
28 as "Exhibit A".

30 Section 3 – The City Manager is directed to cause the appropriate entries to be
31 made in the books and records of the City.

33 Section 4 - This Ordinance shall be in full force and effect from and after
34 passage.

EXPLANATION TO COUNCIL BILL 2018-052

ORIGINATING DEPARTMENT: City Manager's Office

PURPOSE: To authorize the City Manager, or his designee, to accept a grant from the Greene County Senior Citizens' Services Fund Board for the benefit of the Give 5 Program; and to amend the budget of the City of Springfield, for Fiscal Year 2017-2018, in the amount of \$92,350 to appropriate said grant funds.

BACKGROUND INFORMATION: The Give 5 program matches retired, or almost retired, volunteers with innovative volunteer opportunities. The program connects volunteers with opportunities to utilize their skills and assets to give back to their community and fill a wide variety of volunteer needs, such as providing leadership to nonprofits, mentoring children, assisting those most in need, and serving on City and County boards and commissions.

The City applied for and received a grant award from the Greene County Senior Citizens' Service Fund Board to operate the Give 5 program during calendar year 2017. Greene County's fiscal year is January 1 through December 31. If this Ordinance is approved, the City would receive \$92,350 for calendar year 2018. The provisions of the grant stipulate that any funds not expended on the program by December 31, 2018, must be returned to the Greene County Senior Citizens' Services Fund Board. Following the calculation of the 2018 Give 5 expenses, any unspent amount from the 2018 grant award will be returned to the Board.




