16 WHEREAS, the Mayor of the City of Springfield, Missouri, with the advice and
17 consent of City Council, may appoint Springfield Plaza Community CID members.

20 SPRINGFIELD, MISSOURI, as follows, that:

22 Section 1 – The Mayor, with the advice and consent of City Council, hereby
23 reappoints Kirk Juranas, Tim O'Reilly, and Randy Renkel as members of the Board of
24 Directors of the Springfield Plaza CID, to serve a term until October 12, 2021, or until
25 their respective successor may be appointed.


