In February, 2018, Springfield City Council reviewed fee adjustments for various services performed by Hazelwood Cemetery. We are pleased to announce that again there are NO changes this year. Pricing remains the same as last year.

## Definition of Services Provided

### Open/Close – Adult, Infant, Cremains Burial

The charge for preparing the grave site for an adult, infant or cremation remains burial.

### Open/Close – Infant or Cremains Only with Family Preparation

The charge to mark the grave and provide materials for an infant or cremains burial, where the family wishes to prepare the grave. Cemetery Staff ensures proper tamp/close of the grave.

### Additional Fee for Non-Office Hour Services

The charge for Saturday, Sunday, Holiday & Evening/Late burial (in addition to the Open/Close charge) due to the cost of overtime for employees performing the service.

### Disinterment Charges

The charge for removing the remains from a graveside at Hazelwood. **A licensed funeral director (FD) is required by law to be present (Cost of FD services are not included)**. Re-interment will incur additional burial fees if moved to another location at Hazelwood.

### Lot Sales

The charge for each gravesite includes cost of perpetual care and is set at a rate to not undercut the prices charged by local cemeteries. The charge for an infant gravesite is based proportionally to the size of an adult grave. Grave spaces are sold in combinations of two and three grave plots. Mausoleum lots (20'x20') are also available.

### Lot Sales – Historical Graves (none currently avail)

The lot sale charge for researching and verifying gravesites/lots that have been “historically vacant” (ie. never sold/never used) throughout the cemetery.

### Lot Sales – Reinstated Graves (none currently avail)

State statute allows the City to declare “purchased purchased/not used” graves to be abandoned if unused for more than 50 years. The charge for these gravesites covers the cost of filing public notices, recording fees, conducting field study of the lot and research by the City Attorney’s office.
