**HOLD HARMLESS AGREEMENT FOR SPECIAL EVENTS**

**THIS AGREEMENT**, made and entered into this \_\_\_\_ day of \_\_\_\_\_, 20\_\_\_\_, by the Special Event Applicant identified above, hereinafter "Applicant," and the City of Springfield, Missouri, a municipal corporation, hereinafter "City."

1. This agreement shall only be binding upon the parties if Applicant is granted a Special Event Permit by the City.
2. Insurance. Applicant shall at all times during the term of this agreement carry insurance in the amounts and types required for a special event by the Springfield City Code.
3. Applicant, as consideration for the Special Event Permit, hereby agrees to defend, indemnify and hold harmless the City from any and all claims, demands, causes of action, damages, judgments, costs, attorney's fees, and expenses that City may sustain, incur, or become liable for because of loss, destruction, or damage to property and because of injury or death to any persons resulting from any negligence of the Applicant, or Applicant's contractors, agents, or invitees arising out of Applicant's use of City property during the Special Event, and furthermore, agrees to be responsible for all losses, destruction, or damage to any property of the City, arising out of Applicant's use of City property during the Special Event, or from the failure of Applicant to comply fully with Applicant's obligations hereunder. In no event shall City be liable to Applicant or any third person for damage or injury to Applicant's activities or equipment and property placed on City property pursuant to the Special Event Permit. The obligation of Applicant to indemnify City shall survive the termination of the Special Event Permit as to occurrences taking place during the Special Event.
4. This agreement contains the entire agreement of the parties with respect to indemnity. No modification, amendment, or waiver of any of the provisions of this agreement shall be effective unless in writing specifically referring hereto, and signed by both parties.
