



Adult/Dislocated Worker Training Expenditure Rate/Local Criteria for Training Recipients

Training Expenditure Rate

Significant amount of funding is utilized for short term training as requested by clients. In addition, if eligible for Federal Student Aid, (i.e. Pell Grant), these funds often pay for the majority of the training. The training expenditure rate is depicted in the following chart:

The Ozark Region Workforce Board will spend a minimum of 40% of WIOA Adult and Dislocated Work allotments on training and other participant costs, and a maximum of 60% will be spent on staffing and non-participant costs, unless a waiver has been issued.

Local Criteria for Training Participants

The Skills Team operates the WIOA Adult and Dislocated Worker programs. WIOA-eligible individuals who are determined to be unsuccessful at the Career Services level and who have a demonstrated need of marketable skills may be enrolled into Training Services.

General eligibility for the Adult Program is that the individual meets poverty or lower living standard income level guidelines; receives or has received within last six months, or is a member of a family that is receiving or has received in the last six months, SNAP, TANF, or Supplemental Security Income (SSI); is a homeless individual; or is an individual with a disability whose own income meets income guidelines.

Category 1...

Who has been terminated, laid off, received a notice of termination or layoff from employment and, is unlikely to return to a previous industry or occupation.

Category 2...

In addition, those who "may" also qualify are those who have been employed for enough duration to demonstrate workforce attachment but is not eligible for UI due to insufficient earnings or the employer is not covered under the state UI law and is unlikely to return to the previous industry or occupation.



Category 3...

Who is terminated or laid off or has received notice of termination or layoff from employment as a result of the permanent closure or substantial layoff at a plant, facility, or enterprise.

Category 4...

Individuals who are currently employed at a facility at which the employer has made a general announcement that the facility will close.

Category 5...

Individual who were previously self-employed (including farmers, ranchers, and fisherman), but is unemployed due to general economic conditions in the community of residence or due to a natural disaster.

Category 6...

Is a "Displaced Homemaker". A Displaced Homemaker is a person who has been providing unpaid services to family members in the home and has been dependent on the income of another family member but is no longer supported by that income.

OR...

- Is the dependent spouse of a member of the Armed Forces on active duty and whose family income is significantly reduced because of a deployment, a call or order to active duty, a permanent change of station, or the service-connected death or disability of the member;

AND...

Is unemployed or underemployed and is experiencing difficulty in obtaining or upgrading employment.

Category 7...

Individual is a spouse of a member of the Armed Forces on active duty and who has experienced a loss of employment as a direct result of relocation to accommodate a permanent change in duty station of such member.

Category 8...

Individual is the spouse of a member of the Armed Forces on active duty and who is unemployed or underemployed and is experiencing difficulty in obtaining or upgrading employment.

Please note: An applicant statement may be used to verify some of the eligibility requirements. At all times, priority of service is given to eligible veterans and/or spouses.
