- Harmony House underwent monitoring for its' FY2021 grant in April of 2022. This monitoring resulted in two findings. At the time of the monitoring, Harmony House submitted a monitoring response in July of 2022. Following submission of response, Harmony House was not notified until May of 2023 that the submitted response was deemed unsatisfactory. Harmony House submitted a new response to the finding in July of 2023, and is awaiting additional response from HUD at this time.

- Due to challenges in the current local housing market related to a lack of available units within fair market rent value, Harmony House has been unable to expend the entirety of the current awarded budget. Harmony House clients also require additional safety considerations regarding housing, due to their history of domestic violence, making the search for housing difficult. Per guidance from Harmony House's HUD representative, Harmony House was unable to submit a budget amendment request to expend a portion of these funds toward its' HMIS compatible database related to Rapid Rehousing as supportive services were not written into the original grant request.

Harmony House, located at 3404 E. Ridgeview Street in Springfield, MO is Springfield/Greene County's only domestic violence shelter. With 168 beds, we are the largest domestic violence shelter in the state, providing a comprehensive array of services, including 90-days emergency shelter; case management support; court advocacy; on-site domestic violence, substance abuse and children's counseling; on-site civil legal services; life skills classes & support groups; community outreach services; child care; transportation assistance; and housing assistance.

Our proposed renewal project would meet an ongoing need for rental assistance for domestic violence survivors moving from homelessness into safe, secure housing. Harmony House has been fortunate to receive funding from HUD for rental assistance, beginning July 1st, 2019. With our current HUD funding, we are able to cover the cost of first month's rent plus three months' short-term rental assistance for referrals pulled directly from our Continuum of Care's Coordinated Entry System Prioritization List of domestic violence survivors. Referrals are offered ongoing case management and support services through our Community Outreach Program even after they've secure housing.

This renewal will allow us to continue to support an ongoing, critical need for domestic violence survivors in our community and will enable Harmony House to not only provide housing assistance to more people but will also allow them the precious time necessary to become stabilized. Without HUD's continued funding, we will not be able to provide rental assistance to a vulnerable, under-served population.
