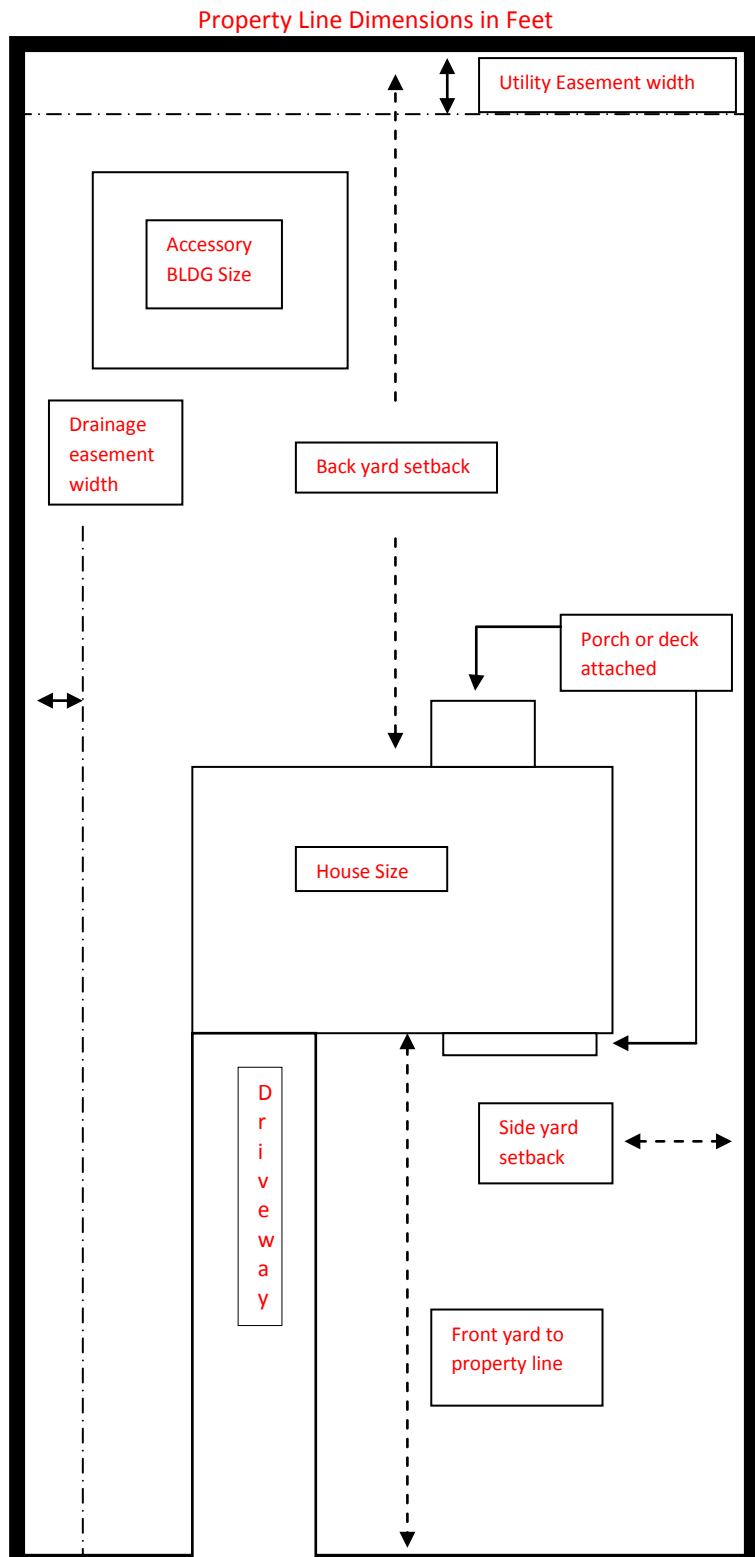
NEW RESIDENTIAL SINGLE FAMILY

Must supply the following:

1. Address
2. Legal description
3. Site plan drawn on scale of 1 inch to 20 ft.
4. Width & depth of lot
5. Set backs in front, sides & rear.
(Zoning ordinance requires Minimum front set back of 25 ft. for streets classified as collector or higher; 15 ft for streets classified as local; 5 ft. on sides; and 10% of lot depth in rear – not less than 10 ft. nor more than 20 ft.)
6. Show all easements (you are allowed to build up to, but cannot have any overhang on an easement)
7. Show driveway location

Misc: Garage doors for residential uses shall be located a minimum of 20 ft. from the side lot line when the vehicular access to a lot is from a street adjacent to the side lot line and the garage door is generally parallel to the side lot line (ref: 5-1302-B)

ACCESSORY STRUCTURE IN RESIDENTIAL SINGLE FAMILY AREA
